## Invitation

### **20 years after Pinochet's arrest: The past and present of transnational justice**

**Wednesday 17 October 2018, 4:30 – 9:00 p.m.**

**Berliner Abgeordnetenhaus, Niederkirchnerstr. 5, 10117 Berlin**

Berlin's past and present reveal several links to severe human rights violations, as well as to efforts to address past atrocities. The International Military Tribunal, which went on to prosecute Nazi crimes in Nuremberg, sat in Berlin on 18 October 1945. In Berlin on 17 October 1998, survivors of Augusto Pinochet's dictatorship celebrated after Pinochet was arrested in London. And in the same year, Berlin-based lawyers, politicians and members of the civil society strove for the establishment of the International Criminal Court.

On the occasion of the anniversaries of these diverse historical events, the parliamentary groups of [Die Linke](#) and [Bündnis 90/Die Grünen](#) in the Berlin House of Representatives together with the European Center for Constitutional and Human Rights ([ECCHR](#)) and the Forschungs- und Dokumentationszentrum Chile-Lateinamerika e.V. (Centre for Research and Documentation Chile-Latin America, [FDCL](#)) will host an event.

Survivors, activists and lawyers from Chile and Germany will discuss how transnational justice can succeed and what still remains to be done.

### Discussion:

#### **Colonia Dignidad – Prosecution of perpetrators in Chile and Germany to date**

The German Federal Public Prosecutor has had the power to prosecute war crimes since 2002. Serious human rights violations (including torture, murder or enforced disappearance) committed before 2002, e.g. during the military dictatorships in Chile or Argentina, fall under the remit of a regular public prosecutor, such as the Chief Public Prosecutor in Berlin. It is still possible that perpetrators of such crimes go undetected in Germany or that, as in the case of Colonia Dignidad, many survivors and perpetrators are German. This panel will discuss the responsibility of public prosecutors and legal authorities in Berlin and the other German federal states to contribute to transnational justice efforts.

**Discussion: Universal Jurisdiction - 20 years from Pinochet to Syria**
